# JANUARY MEMBERSHIP MEETING (25 JAN) National Security

The Colorado Springs (COS), Colorado Chapter of MOWW was honored to welcome Ms. Aleta Jeffress, the National Cybersecurity Center (NCC) Chief Executive Officer (CEO) as our guest speaker during the 25 January 2025 Companion Monthly Membership Meeting. Ms. Jeffress provided an excellent presentation on the mission of the National Cybersecurity Center and its impact to our community and nation. Based in Colorado Springs, the NCC is a 501(c)3 Non-Profit corporation that provides training, evaluations, and specialized expertise to state and local governments as well as corporations and businesses to secure their information technology networks, intellectual property, and infrastructure. The NCC has established relationships with key organizations in government, education, and industry and sponsors programs to build cyber resiliency and collaboration in the security market across Colorado and the United States. Ms. Jeffress is responsible for securing funding, largely through donations, defining the organization's strategy and direction, driving business development, and delivering services to state and local governments, and the public. She previously served in both the private industry, as an executive business leader for CGI, an international IT consulting and services firm, and in the public sector as Chief Information & Strategy Officer and Chief Privacy Officer for the City of Aurora, CO. She is a Certified Information Systems Security Professional (CISSP) with extensive experience in securing the mid-tier infrastructure environment for the Defense Financial Accounting System, the payment system for millions of employees within the Department of Defense. We thank Ms. Jeffress for her service to the nation and for her informative presentation on securing our information technology infrastructure.

The mission of the Human Trafficking Task Force of Southern Colorado is to build a collaboration of organizations and individuals to reduce human suffering caused by human trafficking, through advocacy, awareness, rehabilitation, and services for survivors.

# **NATIONAL PROGRAM – ARTICLE**

Department of Homeland Security (DHS) Human Trafficking

Human trafficking threatens the Nation's physical and virtual borders, immigration and customs systems, prosperity, national security, personal and public safety.

The United States has declared it a national priority to end human trafficking and the importation of goods produced with forced labor. DHS is on the frontlines of this fight, protecting the country and collaborating with partners to stop these crimes.



DHS Center for Countering Human Trafficking. The mission of the DHS Center for Countering Human Trafficking (CCHT) is to advance counter human trafficking law enforcement operations, protect victims, and enhance prevention efforts by aligning DHS's capabilities and expertise. The CCHT is a DHS-wide effort comprised of 16 supporting offices and components and is led by U.S. Immigration and Customs Enforcement (ICE) Homeland Security Investigations (HSI). The CCHT is the first unified, inter-component coordination center for countering human trafficking and the importation of goods produced with forced labor.

Guided by the DHS Strategy to Combat Human Trafficking, the Importation of Goods Produced with Forced Labor, and Child Sexual Exploitation, CCHT integrates the efforts of every component within DHS involved in combating human trafficking. DHS efforts range across criminal investigations, victim assistance, identifying and reporting human trafficking, external outreach, intelligence, and training. The CCHT better equips and positions DHS to accomplish and improve every aspect of its counter human trafficking efforts.



DHS's Blue Campaign is a national public awareness campaign designed to educate the public, law enforcement, and other industry partners to recognize the indicators of human trafficking, and how to appropriately respond to possible cases. Blue Campaign works closely with DHS Components to develop general awareness trainings, as well as specific educational resources to help reduce victimization within vulnerable populations.

Located within the Office of Partnership and Engagement and aligned with the DHS Center for Countering Human Trafficking, Blue Campaign leverages partnerships with the private sector, Non-Governmental Organizations (NGO), law enforcement, and state/local authorities to maximize national public engagement on anti-human trafficking

efforts. Blue Campaign's educational awareness objectives consists of two foundational elements, prevention of human trafficking and protection of exploited persons.

# **NATIONAL SECURITY (NS)**

Combating Trafficking in Persons. The Department of Defense's Combating Trafficking in Persons (TIP) Program Management Office provides personnel the necessary tools to help prevent trafficking in domestic and international environments.

DOD reporting procedures for alleged TIP violations:

- Report anything suspicious that you see to your chain of command.
- Learn the signs and indicators of trafficking in persons
- Never act ALONE, you may want to help, but trafficking situations are dangerous
- Report and avoid any establishments or persons that you believe may be involved in TIP
- Report all suspected abuses through your chain of command or inspector general

# PUBLIC SAFETY/LAW & ORDER (PS/L&O)

Colorado has a number of public safety and law and order measures to combat human trafficking, including a hotline, a council, and legislation.

- Hotline: Call the Colorado Human Trafficking Hotline at (866) 455-5075, 24 hours a day, 7 days a week or Text "Help" to (720) 999-9724
- Council: The Colorado Human Trafficking Council coordinates statewide efforts to prevent and prosecute human trafficking. The council is made up of representatives from state and nongovernment agencies.
- Legislation: Colorado has laws that increase the penalties for human trafficking; protect minors from human trafficking; and laws allow qualified nonprofits to take legal action against human traffickers.

Other resources: The Laboratory to Combat Human Trafficking runs the Colorado Human Trafficking Hotline. This is Human Trafficking has information

about what to look for in human trafficking. If you or someone you know is in immediate danger, you should contact your local police department or sheriff's office.

#### ROTC/JROTC

The academic year is coming to a close and the Chapter is in need of Companions to volunteer to serve as presenters for the numerous JROTC programs at High Schools and the ROTC program at University of Colorado – Colorado Springs (UCCS). Award ceremonies occur in April and May and typically last an hour. Please contact Mike Berendt or Ulysses Swift if you are interested in representing the Chapter as a presenter.

## SCOUTING/CAP

Col Neal contacting Mr. Ric Trimillos with the intent to facilitate a meeting between the USAFA Cadet Eagle Scout Venturing Crew in January or February. Purpose of the meeting is to introduce himself and the Order to the Cadets in pursuit of SG-1 Outreach, and to enlist them for assistance in establishing a relationship between the Cadets and the order Scout recruiting.

Rich Peters continues to engage with USAF Civil Air Patrol unit to integrate with MOWW Awards program.

#### **VETERANS AFFAIRS**

The Honorable Douglas A. Collins was sworn in as the 12th secretary of Veterans Affairs on Feb. 5, 2025, following his nomination by President Donald J. Trump.

A native of Gainesville, Georgia, Collins saw public service modeled by his father, a Georgia State Trooper, and



mother, who provided care to local senior citizens. He earned a degree in political science and criminal justice from the University of North Georgia.

Collins earned his master's degree in divinity from New Orleans Baptist Theological Seminary, and his community roots deepened in the eleven years he pastored Chicopee Baptist Church. In 2006, the people of Georgia's 27th State House District elected Collins to represent them. During his first term in the state legislature, Collins graduated from Atlanta's John Marshall Law School and established his own legal practice.

As a U.S. Air Force Reserve chaplain, Collins has ministered to our country's military since 2002. He

completed a 2008-2009 deployment to Iraq while stationed at Balad Air Base. He remains a colonel in the Air Force Reserve.

Collins served as a U.S. Representative for Georgia's Ninth Congressional District from 2013-2021. While Collins is a public servant, attorney, and practicing military chaplain, he remains foremost a husband to Lisa and father to daughter Jordan and sons Copelan and Cameron. Lisa was a lifelong educator in Georgia's public schools, and together she and Doug are actively involved at Lakewood Baptist Church. (See this link for Presidential Appointees to the VA.)
